### 2.3 PAYMENT FOR SERVICE

#### 2.3.2 PAYMENT OF BILLS (Cont'd)

J. In deciding on the reasonableness of a particular agreement, the Company will take into account the customer's ability to pay, the size of the unpaid balance; the customer's payment history and length of service, and the amount of time and reasons why the debt is outstanding.

#### K. Returned Payments

A nonrecurring charge will apply for each payment returned by the customer's designated financial institution for reasons such as non-sufficient funds, account closed, payment stopped, etc.

#### NONRECURRING CHARGE

- Returned Payment Charge **\$30.00** (I)

#### L. Late Payment Charge (OAR 860-21-126)

1. A late payment charge will apply to accounts not paid in full each month and leaving an unpaid balance of \$30.00 or more to be carried forward.
2. The late payment charge will be listed separately and included in the total amount due on the current bill.
3. The minimum late charge is \$0.50.
4. The rates of interest paid will be established annually by the Oregon Public Utility Commission, in accordance with Oregon Administrative Rule (OAR) 860-21-126.
5. In accordance with OAR 860-21-126(3) and OAR 860-34-120(2), the applicable monthly interest rate will be established annually by the Oregon Public Utility Commission.
