This filing is made in compliance with the Federal Communication Commission’s (FCC) Order 20-143; Part 51 – Interconnection; Subpart M – 8YY Transition; §51.909 Transition of rate-of-return carrier access charges; Step 3. The FCC Order further established a three step glidepath reduction to a

uniform, nationwide toll free database query rate. Step 3 requires interstate and intrastate originating End Office Access Service rate elements for Toll Free Calls to be reduced by one-half. The 7 companies propose a reduction to the required rate level.

It is requested that this filing become effective July 1, 2022.
