Re: Advice No. 24-012—Schedule 117—Transportation Electrification Residential Charging Pilot

In compliance with ORS 757.205 and OAR 860-022-0025 PacifiCorp d/b/a Pacific Power (PacifiCorp or Company) submits for filing the following modified tariff page associated with Tariff P.U.C. OR No. 36, which sets forth all rates, tolls, charges, rules, and regulations applicable to electric service in Oregon. The Company respectfully requests that the Public Utility Commission of Oregon (Commission) approve an effective date of June 12, 2024. A less than statutory notice application is included with this filing.

Purpose

The purpose of this filing is to modify PacifiCorp's Transportation Electrification Residential Charging Pilot (Schedule 117) to address feedback the Company has received regarding the Special Condition 1.

Background and Proposal

From September 18, 2023, through October 20, 2023, PacifiCorp offered a limited-time-offer rebate under Schedule 117 to provide customers an instant electric vehicle (EV) charger rebate to reduce or cover the cost of a qualified EV charger for the purpose of charging an electric vehicle at home. After enrolling customers in the program, which included initiating billing customers under the Residential Time-of-Use pilot (Schedule 6), several customers notified the Company that they did not want to be billed under Schedule 6, citing they were either unaware that they would be billed under Schedule 6 or that the information they received did not clearly communicate that would occur. At least one customer contacted the Commission with these concerns.

In response to this feedback, PacifiCorp is proposing to modify the language in Special Condition 1 to clarify that customers who are enrolled in the Time-of-Use rate (Schedule 6) through Schedule 117 will not be subject to the provision of Schedule 6 that requires customers to remain on the rate for one year.

Tariff Changes and Impacts

In addition to stating the tariff schedule change, OAR 860-022-0025 requires PacifiCorp submit the number of customers affected, the change in revenue, and the grounds supporting the change. As of the date of this filing, there 629 customers that were enrolled in Schedule 6 through Schedule 117 who could be impacted by this change. PacifiCorp does not know how many of the 629 customers enrolled in Schedule 6 through Schedule 117 would elect to be billed under a different rate schedule, but any potential change in revenue that could result from approving this tariff change would be insignificant.

Income Eligible Rebate

L2 Charger Up to \$1,500, capped at 100 percent of qualified costs

240 V Outlet Rebate \$500 rebate for installation of a 240 V outlet, capped

at 100 percent of qualified costs

Income Eligibility

Low-income qualified customers demonstrate eligibility through participation in low-income programming, including the Oregon Energy Fund, Low Income Home Energy Assistance Program, or the Oregon Energy Assistance program. Special Conditions

- 1. Residential Customers receiving a Standard Rebate will automatically be enrolled in the Residential Time-of-Use Pilot Schedule 6. The requirement in Schedule 6 that Customers remain on Schedule 6 for a term not less than one year will not apply to Customers enrolled in Schedule 6 through this Pilot. Customers may opt out of Schedule 6 at any time by notifying the Company.
- 2. Residential Customers receiving an Income-Eligible Rebate will have the option to enroll in Schedule 6.
- 3. To be eligible for an incentive, Customers must submit a Program Administrator approved post-purchase application and meet all Program requirements.
- 4. Incentives will be available on a first come first served basis with an overall port and threeyear program cap.
- 5. The Company and its agents reserve the right to inspect installations.
- 6. Applications may be subject to charger and per project caps.
