Please find the following revisions to Monitor Cooperative Telephone Company's Tariff P.U.C. Or. No. 3, Access Service.

Monitor Cooperative Telephone Company ("Monitor") concurs with the terms and conditions of the Stayton Cooperative Telephone Company, Inc. Tariff P.U.C. Or. No. 4, and files its own rates and charges in Monitor's own P.U.C. Or. No. 5 Access Service Tariff. This filing is made in compliance with the Federal Communication Commission's (FCC) rules, which require National Exchange Carrier Association ("NECA") member companies to adjust their capped interstate switched access rates for July 2, 2024. NECA has informed its member companies that pool election changes for the upcoming tariff year will decrease rates by 2.4921 percent. On June 17, 2024 NECA will file with the FCC modified rates for interstate, intrastate terminating access rates (which will be in parity with interstate rates) and the required end office element rate step-down in accordance with federal rules.

The state terminating switched access rate changes match the CAF ICC Intrastate Tariff Rate Plan (TRP), which are proposed for July 2, 2024.
