Pursuant to ORS 757.268 and OAR 860-022-0041, PacifiCorp encloses with this letter its highly confidential tax report for 2009. The enclosed tax report is being filed under seal pursuant to Protective Order No. 06-033 (2006). Under the terms of Protective Order No. 06-033, PacifiCorp will also make its highly confidential 2009 Tax Report and supporting workpapers available to Qualified Intervenors in the Portland and Salem safe rooms by Friday, October 22, 2010. The highly confidential information contained in the report is privileged under state law and protected from disclosure under ORS 757.268(11) and ORS 192.502(9).

The tax report discloses the difference between the amount of state, federal, and local taxes paid and properly attributed to the regulated operations of the utility and the amount of taxes authorized to be collected in PacifiCorp's rates for calendar year 2009, which PacifiCorp calculated based on the requirements of ORS 757.268 and OAR 860-022-0041. These calculations show that, for calendar year 2009, the amount of state, federal, and local taxes paid and properly attributed to the regulated operations of the utility was \$29,347,278 more than the amount of taxes authorized to be collected in PacifiCorp's rates as determined pursuant to ORS 757.268 and OAR 860-022-0041. With interest, this amount would result in an approximate 3.1 percent increase over present rates including the current SB 408 surcharge.

Based on PacifiCorp's tax reports previously submitted, the state, federal, and local taxes paid and properly attributed to the regulated operations of the utility was \$4,478,824 more than the amount of taxes authorized to be collected in PacifiCorp's rates for calendar year 2007; and \$1,448,453 more than the amount of taxes authorized to be collected in PacifiCorp's rates for calendar year 2008.

In each of the three years contained in the highly confidential tax report, the amount of taxes reflected in PacifiCorp's rates differed from the amount of taxes paid by \$100,000 or more. Under ORS 757.268(4) and OAR 860-022-0041(8), the Commission previously established an automatic adjustment clause under ORS 757.210 for the difference between taxes paid and collected on or after January 1, 2006.

PacifiCorp will file tariff sheets effective June 1, 2011, in compliance with the Commission's order on the 2009 Tax Report.
