20	Northwest Natural Gas Company, dba NW Natural (NW Natural or				
21	Company), hereby files with the Public Utility Commission of Oregon (Commission) this				
22	application for reauthorization (Application) to use deferred accounting pursuant to ORS				
23	757.210 and 757.259, and OAR 860-27-300, for the 12-month period beginning				
24	November 1, 2008. The Company's last reauthorization commenced November 1,				
25	2007, and, therefore, the existing 12-month reauthorization period has not yet expired.				
26	This instant application seeks reauthorization for the period beginning November 1,				
27	2008 through October 31, 2009.				
28	NW Natural requests that, as part of its reauthorization, the Commission				
29	approve NW Natural's automatic adjustment clauses and the Purchased Gas				
30	Adjustment (PGA), pursuant to ORS 757.210(1). See Order Nos. 89-1046, 99-272, and				
31	99-697.				

1	Specifically, in this Application, NW Natural requests reauthorization to				
2	defer:				
3	A. One hundred percent (100%) of the difference between the gas cost demand				
4	charges collected from rates and the actual gas cost fixed/demand charges experience				
5	by the Company as previously authorized in Order Nos. 89-1046, 99-272, and 99-697;				
6	B. The commodity charge variation as defined in NW Natural's Tariff P.U.C. Or.				
7	24 Schedule P, or its successor, and;				
8	C. All previously-authorized account balances related to lost margin and DSM				
9	program costs, and PGA commodity and capacity cost deferrals not presently				
10	authorized for amortization, or being proposed for amortization, all as described in NWN				
11	Advice No. OPUC 08-5.				
12	In compliance with the requirements of OAR 860-027-0300(4), NW				
13	Natural hereby submits the following information:				
14	1. A description of the utility expenses or revenues for which deferred				
15	accounting is requested:

7	received by ratepayers."					
8	3.	The accounts proposed for recording the amounts to be deferred and the				
9	accounts that would be used for recording the amounts in the absence of approval of					
10	deferred ac	counting are as follows:				
11		a. The charges incurred for gas costs pursuant to the PGA activity				
12	and other in	curred gas costs, absent the requested account 191 deferral, would be				
13	recorded as increases/decreases in the appropriate 401 gas expense subaccount.					
14	4.	An estimate of the amount to be recorded in the deferred accounts for the				
15	12-month p	eriod subsequent to the Application is attached as Exhibit A. Because of				
16	market fluct	uations, capacity and commodity deferral amounts are impossible to				
17	estimate. E	ecause the Collection vs. Incurred Demand account reflects cyclical				
18	collection d	fferences rather than market fluctuations, an estimate for this account is				
19	included.
