PACIFICORP'S APPLICATION FOR DEFERRED ACCOUNTING

I. INTRODUCTION

Under ORS 757.259 and OAR 860-027-0300, PacifiCorp. d.b.a. Pacific Power 2 3 ("Company") applies to the Public Utility Commission of Oregon ("Commission") for an 4 order authorizing the Company to defer from the date of this Application forward the costs associated with an independent evaluator ("IE") selected by the Commission for the 5 6 Company's solicitation process for renewable resources known as the 2008R-1 Request for 7 Proposals ("2008R-1 RFP") to the extent these costs are not otherwise recovered through 8 bidder success fees as set forth in the approved 2008R-1 RFP. 9 **II. 7	III. DEFERRED ACCOUNTING RULE REQUIREMENTS
8	The following information is provided pursuant to the requirements set forth in OAR
9	860-027-0300(3).
10	A. Description of Utility Expense.
11	On March 4, 2008 PacifiCorp filed its application for approval of the 2008R-1 RFP
12	with the Commission, under the competitive bidding guidelines established in Docket No.
13	UM 1182, Order No. 06-0446 ("RFP Order"). This filing was assigned Docket No. UM
14	1368.
15	Guideline 5 of the RFP Order requires an Independent Evaluator ("IE") in all RFPs.
16	Guideline 5 provides that a utility may request deferred accounting to track the costs of an
17	IE for later inclusion in rates. Also in the application for approval of the 2008R-1 RFP, the
18	Company included a draft request for proposals for an Oregon IE. After receiving
19	comments from Commission Staff, ¹ the Company issued the final IE RFP on March 20,
20	2008. Staff recommended selecting Boston Pacific Company, Inc. ("Boston Pacific") as the
21	IE for the 2008R-1 RFP. Staff based this recommendation on several reasons, one being
22	Boston Pacific receiving the highest ranking based on the scoring criteria contained in the
23	IE RFP. At the Commission Public Meeting on May 6, 2008, the Commission approved
24	Staff's recommendation and selected Boston Pacific. See Staff Report, Docket No. UM
25	1368 (May 6, 2008 Public Meeting). The Commission also approved Staff's
26	recommendation that the Commission direct PacifiCorp to negotiate a contract with Boston

Pacific consistent with the RFP Order and subject to Staff's review. PacifiCorp executed
 the contract with the Oregon IE and regularly consults with the Oregon IE under the terms
 of the contract.

At the September 18, 2008 Public Meeting, the Commission approved the 2008R-1 4 5 RFP (See Order No. 08-476). The 2008R-1 RFP requires successful bidders to submit a fee, which will be used to cover the costs of the Oregon IE. Because the Company expects the 6 7 costs to be covered be the successful bidders' fees, the Company does not expect the 8 deferral to be necessary absent unexpected circumstances (e.g. lack of sufficient successful 9 bidders to cover the full cost). Therefore, this application seeks deferred accounting for 10 costs incurred under the Oregon IE contract only to the extent such costs are not otherwise 11 recovered from the successful bidders.

B. Reasons for Deferral.

ORS 757.259(2)(e) allows the deferral of utility expenses or revenues where necessary to match appropriately the costs borne by and benefits received by customers. This request seeks to align the costs of the Oregon IE and the services that the Oregon IE performs on behalf of customers. In its RFP Order, the Commission specifically approved of the use of deferred accounting to match the customer costs and benefits of an IE in this manner.

19 C. Proposed Accounting.

During the period of deferral, PacifiCorp proposes to account for the deferred costs of the Oregon IE by recording the deferral in Account 182.3, Other Regulatory Assets. PacifiCorp requests that in accordance with ORS 757.259(4), it be allowed to accrue interest on the unamortized balance at a rate equal to its weighted average cost of capital most recently approved by the Commission. Amortization of the balance would be considered in a subsequent proceeding coincident with inclusion in rates.

26 D. Estimate of Amounts.

PacifiCorp anticipates that the cost of the IE will be approximately \$500,000.

5 PacifiCorp respectfully requests that, in accordance with ORS 757.259, the

6 Commission authorize the Company to defer the costs described in this Application.

NOTICE OF APPLICATION

On October 3, 2008, Applicant PacifiCorp, d.b.a. Pacific Power ("Company") applied 1 2 to the Public Utility Commission of Oregon ("Commission") for authorization to use 3 deferred accounting.

4 The Company proposes to defer from the date of the application forward the costs associated with an independent evaluator ("IE") selected by the Commission for the 5 6 Company's 2008R-1 Request for Proposals for Renewable Resources that are not otherwise 7 recovered through the bidder success fee mechanism. The Company expects the annual 8 deferral amounts could be up to \$500,000. The Company requests that the deferral continue 9 no longer than twelve months from the date of this filing.

10 The granting of the Application will not authorize a change in rates, but will permit 11 the Commission to consider allowing such deferred amounts in rates in a subsequent 12 proceeding.
