23	minimize the frequency of rate changes or the fluctuation of rate levels or to match appropriately		
24	the costs borne by and benefits received by ratepayers."

1	The	e Company requested an extension of the deadline agreed to in stipulation in UW 174		
2	for filing a new general rate case. During staff's investigation into the validity of the request,			
3	Staff discovered that rate case amortization portion of expenses that the Company recovers in			
4	rates should expire on December 31, 2023, and represents about 10 percent of the Company's			
5	operating expenses. Should the Company's requested rate case filing extension be granted, the			
6	Company	stands to potentially collect additional rate case amortization expenses for a full year		
7	beyond what was agreed to in Stipulation. <sup>2</sup> Hence, Staff submits this application to defer further			
8	collection of rate case expenses for later ratemaking treatment.

14	over a period of five years effective January 1, 2019. Staff files its Application in order to defer,		
15	for potential later ratemaking treatment, the difference between Government Camp's current		
16	rates and its currently approved rates inclusive of the Company's rate case expenses. Approval		
17	of Staff's Application will not authorize a change in Government Camp's rates, but will permit		
18	the Commission to consider allowing such deferred amounts in rates in a subsequent proceeding.
