INTRODUCTION

Portland General Electric ("PGE") appreciates the opportunity to file comments in this rulemaking.

OAR 860-011-0080

(3) PGE suggests that we add after the second sentence the following sentence: "For these purposes, authorization by E-mail will be considered written authorization."

OAR 860-011-0080

(4) After the comma in the first sentence, PGE suggests inserting the words "prior to any release of such information," to make it clear that the Commission intends to honor the designation of confidentiality for the information while the process described in the rest of the rule is followed through.

OAR 860-011-0080

(5) PGE suggests that we eliminate the words "consider the information public" from the second sentence. The issue is not whether the information itself is public, but whether the record that is being requested can properly be released by the Commission. PGE suggests that the language in the rule should stick to addressing the actions that will be taken under the circumstances.

OAR 860-011-0100

(1) PGE believes it would be better to make it clear to whom the submission must be made in order to trigger the application of the rule. Therefore, we suggest adding the words "to the Commission or Commission Staff" after the word "submitted" in the first sentence of this subsection.

OAR 860-011-0100

(3) The words "included in a filing" in the first sentence are too restrictive, because, as we discussed in the workshop, sometimes the requested information does not relate to a "filing" per se. PGE suggests that we replace the words "included in a filing" with "submitted pursuant to this rule" in the first sentence of this subsection.

CONCLUSION

We appreciate the opportunity to provide these comments in addition to our oral comments regarding process of burden of proof that we understand will be incorporated into the next draft of the rules.
