

To the Commissioners,

Please be fully aware and proceed accordingly, that Least Cost and Least Risk alternatives to this transmission line application have not been comprehensively and systematically researched nor vetted.

It is critical and incumbent upon the Commissioners to ensure that reasonable and currently feasible alternatives are researched and vetted by third party assessment to protect the Rate Payers now and long into the future.

Is this not THE most important mission of the OPUC?

It appears that the OPUC is merely checking off 'application process' boxes and not providing the rigorous protections that Oregonians expect and deserve.

Be sure, Idaho Power Corporation, as for-profit monopoly, is intent on serving its stock holders, not the Rate Payers of Oregon. Every single document they provide, and every supposition and supposed 'fact' should be acutely examined with this knowledge at the forefront of all considerations. Is this occurring?

Who in the OPUC can guarantee to the rate payers of Oregon that you have verified the hundreds of thousands of propositions in the Idaho Power application? Are you being the fire-wall for the Rate Payers and the environment of Oregon?
