Dear ALJ Grant:

This letter is in response to PacifiCorp's letter dated January 22, 2008. In that letter, PacifiCorp stated that the Industrial Customers of Northwest Utilities ("ICNU") responded to PacifiCorp's proposal for handling "highly confidential" information by objecting to the terms of the Protective Order and failing to propose an alternative solution. ICNU wishes to clarify the record.

In its response to PacifiCorp, ICNU stated that ICNU would be unable to reference the bates numbering because ICNU's consultant did not have a copy of the documents and would be unable to draft testimony in the Safe Room. Thus, ICNU could not comply with PacifiCorp's proposal of specifically referencing "highly confidential" documents using the bates numbering. As evident in ICNU's Direct Testimony filed January 22, 2008, no reference was made to "highly confidential" information due to these constraints.
