**Re: UE 177: ICNU's Response to PacifiCorp's Motion for Clarification**

Dear ALJ Allan Arlow,

On July 16, 2008, PacifiCorp d/b/a Pacific Power ("PacifiCorp" or "the Company") filed a Motion for Clarification on the application of Order No. 06-507 and Order No. 08-263 in UM 1147 to Pacific Power's SB 408 balancing account. On July 21, 2008, the Industrial Customers of Northwest Utilities ("ICNU") filed a Response to PacifiCorp's Motion for Clarification ("Response").

PacifiCorp does not plan to file for leave from the Commission to reply to ICNU's Response. This decision is based on the fact that ICNU did not raise any new issues in its response, not because PacifiCorp agrees with any aspect of ICNU's Response. PacifiCorp continues to request that the Commission clarify the application of its orders in the UM 1147 docket in the manner outlined in PacifiCorp's Motion for Clarification.
