The Industrial Customers of Northwest Utilities ("ICNU") submits this reply to PacifiCorp's response to Staff's stipulated motion to amend the procedural schedule. Although all parties agreed to Staff's revised schedule, to accommodate the vacation plans of its legal counsel, PacifiCorp now seeks to move the hearing in this proceeding to September 8, 2008, opening briefs to September 22, 2008, and reply briefs to October 2, 2008. As an alternative, PacifiCorp proposes that the hearing be held during the week of September 15, 2008, with an additional abbreviation in the briefing schedule.

Although ICNU initially objected to PacifiCorp's proposed dates, ICNU has readjusted its schedule to accommodate PacifiCorp's request. PacifiCorp's alternative schedule of holding the hearing during the week of September 15, 2008, would be harmful and could unacceptably shorten the time for briefing. Although a September 8, 2008 hearing date is also highly inconvenient and requires schedule adjustments for ICNU, it is still preferable to holding the hearing during the week of September 15, 2008. Therefore, in the interests of compromise and to ensure an adequate opportunity to prepare legal briefs, ICNU is willing to accept
