9	On June 5, 2008, Staff filed a Stipulated Motion to Amend the Procedural Schedule		
10	("Motion") in this case. Staff filed this Motion "to allow staff (and the other parties)		
11	additional time to prepare their cases."		
12

14	PacifiCorp, however, does have a concern about the new proposed hearing date of		
15	September 4, 2008, because its counsel will be out of town from August 22, 2008 (the		
16	date of rebuttal testimony is due in the new schedule) through September 2, 2008, leaving		
17	only one day for hearing preparation upon her return. PacifiCorp contacted Staff about its		
18	concerns about the hearing date on June 4, 2008 prior to Staff filing its Motion, but time		
19	constraints did not permit PacifiCorp and Staff to resolve this issue in advance of the filing		
20	of the Motion.		
21	PacifiCorp therefore requests that the hearing in this case be set on Monday,		
22	September 8, 2008, or any date thereafter that is available for the Commission and the		
23	parties. PacifiCorp contacted all of the parties by e-mail on Friday, June 6, 2008, and		
24	proposed an alternative hearing date of September 8, 2008, with opening and reply briefs		
25	due on September 22 and October 2, respectively. ICNU responded to this proposal,		
26		ct the week of September 8, 2008. No other	

1	party objected to the alternative hea	ring and briefing dates. Depending on the nature of
2	ICNU's conflict, the hearing may ne	ed to be set the week of September 15, 2008, with a
3	more expedited briefing schedule.	
4	Based upon the foregoing, PacifiCorp requests that the ALJ grant Staff's Motion to	
5	amend the procedural schedule with a new hearing date on or after September 8, 2008,	
6	that accommodates the schedule of the Commission and the parties.
