Re: UE 416 – Portland General Electric General Rate Case, Request for a General Rate Revision

Dear Filing Center:

This letter seeks to supplement the record of the above-captioned docket regarding access to Highly Confidential Information under Order No. 23-138.

On Tuesday, May 16, 2023, I emailed PGE relaying that I intended to submit Signatory Pages to Modified Ord. No 23-138 submitted by NWEC, NRDC, & GEI for UE 416. I then filed the Signatory Pages to Modified Ord. No 23-138 submitted by NWEC, NRDC, & GEI for UE 416 with the PUC filing center shortly thereafter.

That same day, Ms. Burton, Assistant General Counsel III for PGE, emailed me stating that "PGE does not plan to object to the signatories having access to the highly confidential material." *See* Attachment A.

On Wednesday, May 17, 2023, Mr. Rivas emailed PUC staff seeking clarification about the ability to access the highly confidential information in UE 416. PUC staff responded that access would be granted in five business days but that if Mr. Rivas could confirm that PGE did not object, that access could be granted prior to the five-day objection period. *See* Attachment B. In a separate email to PUC staff, Mr. Rivas forwarded the email chain that included Ms. Burton's email. *See* Attachment A. PUC staff then provided NWEC, NRDC, & GEI access to Highly Confidential Information on only May 17, 2023.

On Monday, May 22, 2023, I spoke with Ms. Burton, and she confirmed that she does not object to NWEC, NRDC, & GEI accessing Highly Confidential Information in UE 416.
