Attached for electronic filing is Idaho Power Company's ("Idaho Power" or "Company") Response to Administrative Law Judge ("ALJ") Mellgren's Bench Request issued on March 25, 2024, wherein ALJ Mellgren requested Idaho Power provide a breakdown of all filed or anticipated rate adjustment requests that could result in a rate adjustment effective between now and October 15, 2025. The Company currently has three filings under consideration by the Public Utility Commission of Oregon "(Commission") that are expected to result in a rate adjustment effective before October 15, 2024¹: (1) UE 425 (Annual Power Cost Update), (2) UE 437 (Power Cost Adjustment Mechanism), and (3) UE 426 (General Rate Case).

The table below summarizes the open cases that could result in a rate adjustment prior to October 15, 2024.
