Dear Oregon Public Utility Commissioners and Staff:

The undersigned organizations (the "Energy Advocates") support the Oregon Citizens' Utility Board's (CUB) Motion to Dismiss or Segregate Certain Issues in docket UE 435, Portland General Electric's (PGE) rate case filed on February 29, 2024. We share CUB's concern with PGE's request to re-litigate many of the issues resolved in the Company's last rate case, including a request to increase shareholders' return on equity and to shift risks to customers.

PGE asked for this rate case less than two months after customers first felt the significant shock of its January 2024 rate increase in bills that also included higher use as a result of the winter storm. PGE's request also comes at a time when our communities are feeling the pain of price increases across the economy while wages are not keeping up. PGE's past and proposed increases disproportionately impact environmental justice communities and the many other community members already experiencing energy insecurity, and effectively reduce or eliminate the relief that low-income customer discounts offer.

² According to the Oregon Department of Energy, 24% of Multnomah County residents were energy burdened as of 2020. We expect this is likely an undercount given all that has happened during the last four years.

Now is not the time to increase shareholder profits or shift risk to customers. As CUB noted, adjustments in addition to the 2023 rate case have caused PGE customers to see their bills increase by about 1/3 since December 2022. In the context of such steep increases, PGE's request is unreasonable and amounts to too much too soon. As a result, we ask that you please grant CUB's Motion to Dismiss or Segregate Issues. Thank you for considering our concerns.
