At the August 9, 2007, hearing in these matters, Judge Grant asked the parties to submit, within one week, a survey of states having statutes similar to ORS 756.185. Utility Reform Project (URP) and the Class Action Plaintiffs (CAPs) offer this response. States with statutes similar to ORS 756.185 are listed below. The statutes cited pertain to public utilities, except where noted otherwise. If a state has a statute similar to ORS 756.185 applicable to public utilities, then we do not list that state's other similar statutes applicable to telecommunications utilities, railroads, carriers, etc.

Various courts have determined whether statutes similar to ORS 756.185 are available for use by ratepayers as a remedy for unlawful utility charges. See, e.g., *Keco Industries v. Cincinnati & Suburban Bell Telephone Co.*, 166 Ohio St 254, 141 NE2d 465, *cert denied*, 355 US 182, 78 SCt 267, 2 LEd2d 187 (1957). The outcome in these cases appears to be determined by whether the remedies offered by the regulatory agency are considered exclusive. In Oregon, *Dreyer v. Portland General Electric Co.*, 341 Or 262 (2006), determined that the agency remedies for ratepayers are not exclusive, thanks at least in part to ORS 756.200, and that ratepayers who paid unlawful charges have a cause of action for damages against the utility. Several states have statutes similar to ORS 756.200.
