## RE: UM 1158 – Comments of Portland General Electric Company on the Proposed 2013 Performance Measures for the Energy Trust of Oregon

Portland General Electric appreciates the opportunity to comment on the proposed 2013 performance measures for the Energy Trust of Oregon (ETO), which defines minimum expectations for the ETO's performance. Setting, monitoring and evaluating ETO performance is important to achieving the energy efficiency and renewables targets in our IRP. PGE offers these comments:

- As AR 564 (data sharing between utilities and the Energy Trust of Oregon) is fully implemented, the ETO will have more opportunities to do marketing on its own, not solely to customers who have participated in programs or through the utilities. PGE requests that the ETO measure the costs per customer acquired for mass marketing efforts it undertakes, with an eye to using the most cost-effective channels.
- Ongoing support for the development of renewable resources is also important to PGE. We believe that cost-effectiveness should be a key criterion in evaluating which projects ETO supports. We recommend a 2013 performance measure be added to the ETO report for the cost per kw of installed renewables.

Thank you again for this opportunity to comment. PGE appreciates the Energy Trust's delivery of energy efficiency for PGE customers; it is integral to our resource plan to serve customers.
