Pursuant to OAR § 860-013-0050, the Industrial Customers of Northwest Utilities ("ICNU") submits this Response in Support of the Citizens' Utility Board's ("CUB") Motion to Modify the Schedule in Public Utility Commission of Oregon ("OPUC" or the "Commission") Docket No. UM 1209. Modifying the schedule at this time is appropriate and necessary to ensure that the Commission is presented with the most complete record possible in determining whether MidAmerican Energy Holdings Company's ("MEHC") proposed acquisition of PacifiCorp provides net benefits to customers and is in the public interest. The Commission has made clear that it intends to review MEHC's Application on an expedited basis; however, that review should not occur at the expense of a fully developed record.

As the schedule currently stands, the Applicant's will have the opportunity to submit rebuttal testimony on December 12, 2005, that will respond to Staff's and intervenors': 1) Opening Comments; and 2) Direct testimony. Staff and Intervenors have no opportunity provide written testimony in response to the Applicants' rebuttal testimony. In addition, although it has been indicated that Staff and intervenors may have the opportunity to respond to PAGE 1 – RESPONSE OF ICNU IN SUPPORT OF CUB'S MOTION TO MODIFY SCHEDULE

Applicant's rebuttal testimony at the hearing, it is unlikely that such a response will be as effective as providing written surrebuttal testimony. The current schedule has fourteen business days between the Applicant's rebuttal testimony on December 12, 2005, and the Opening Presentations to the Commissioners on January 4, 2005. The opportunity to conduct discovery and prepare for hearing during this period already is limited. Requiring Staff and intervenors to prepare surrebuttal testimony during this period as well will only further hinder the ability to create a fully-developed record.

ICNU supports CUB's request for the reasons set forth in the Motion. ICNU requests that the CUB's Motion be granted, and that the schedule in this proceeding be revised accordingly.
