Solar Energy Solutions, Inc. opposes the motion of RNP and CUB for an order allowing another round of opening and closing comments on the issue of solar cost data.

From October of 2009 to March 24th, 2010 the cost of the major components for installing a 2 kW – 10kW have only come down and average of \$.14 / watt. Meanwhile, installation and other costs of doing business continue to creep up at almost this exact same rate. We have spent endless hours and even days calling all around the country looking for where we could buy quality systems for the blow out prices being sung about around campfires at night. Our research, much to our disappointment, has proven as fruitless as our search for Big Foot. Systems have not come down significantly in price since October 2009. Therefore, we do not believe further data is relevant or needed at this time. To start the process all over again, we estimate, would take no less than 2 months to do it well.

Solar Energy Solutions, Inc. greatly regrets not seeing eye to eye on this important issue with the above noteworthy organizations. However, Solar Energy Solutions, Inc. believes the solar cost data the PUC has already is more than adequate and accurate enough to help in the determination of a FIT that will make this pilot program a huge success.

For the foregoing reason, the motion should be denied.
