Ms. Walker:

PGE acknowledges it has received the motion for prehearing conference. PGE objects to the motion and to expedited process. PGE has not yet been served with a complaint or any motion for injunctive relief. It is inappropriate to schedule a hearing before PGE has even seen the complaint or motion.

In addition, Zena Solar's motion for hearing suggests that the complaint will be about an issue (the end of the 15 business day period established by OAR 860-082-0025(7)(e) for Zena Solar to execute the interconnection agreement) about which Zena Solar has had notice for weeks or months. Zena Solar could have filed a complaint and motion for injunctive relief well ahead of today and did not need to place PGE or the ALJ in the position of a rushed hearing before a complaint has been filed.
