18	responses attached to the response by CRRWC	dated August 28, 2008.
19	Staff did not receive the responses to Da	ata Requests Nos. 176, 179, 181, 182, and 183
20	until August 28, 2008, as attachments to the Co	mpany's motion. The ALJ correctly notes that
21	the data requests were dated May 29, 2008. He	wever, the responses were not due until June 12,
22	2008. Attached to this response, is an excerpt of	of the Docket UW 120 Data Request Log that
23	highlights data requests 177 through 183. As the	ne report indicates, the data responses were not
24	previously submitted by the Company. The Co	mmission should note that the data request letter
25	specifically highlights the person the requests s	hould be forwarded to. Data request responses
