At this point, the Commission wishes to investigate the complaint and if possible reach a resolution. The PUC is holding an informal meeting at which the plaintiff, the investigative committee and the party that made the complaint may discuss the alleged violation. The meeting is not a formal administrative hearing. It is an informal session at which we can hear from the party who brought an alleged violation of the OUNC rules to our attention and from whom the violation is alleged. After the investigative committee has heard from both, they will make a recommendation in order to settle the matter. The recommendation may be to drop the matter, to issue a warning letter to the alleged violator or to impose a civil penalty. If a civil penalty is recommended, they may also recommend that some or all of it be suspended for various reasons. There will be no court reporter present to make a transcript of the meeting and if the complaint ever goes to a formal administrative hearing, no statements made at this informal meeting will be used as evidence at that formal hearing.

The informal meeting is scheduled for Tuesday, December 19, 2017 at 9:00 a.m. and will be held in the Oregon Public Utility Commission's First Floor- Main Hearing Room at 201 High St. SE, Suite 100, Salem, OR 97308.

Please confirm your attendance by contacting PUC analyst Karla Hunter at 503-373-0044.

You may also choose to participate in the meeting through a conference call rather than attending in person. If you would like to attend the meeting via conference call please let Karla know and she will make arrangements. However, it is important that you submit in advance all evidence materials that you would like the committee to review for the case. If attending the meeting via conference call, please e-mail your meeting materials to karla.hunter@state.or.us one week prior to the meeting date.
