**RE: Docket UE 246 – 2012 General Rate Case  
Mona-to-Oquirrh Project Costs through February 28, 2013**

In compliance with Order No. 12-493 in this docket, PacifiCorp d/b/a Pacific Power (PacifiCorp or Company) submits the enclosed accounting data to facilitate the stipulating parties' audit and review of the costs of the Company's Mona-to-Oquirrh transmission project, as required by the order and consistent with the terms of the multi-party partial stipulation. The Company requested a separate tariff rider for recovery of the Oregon-allocated costs of its investment in the Mona-to-Oquirrh transmission project, to become effective once the project is placed in service. On December 20, 2012, the Public Utility Commission of Oregon (Commission) approved the Company's request in Order No. 12-493.<sup>1</sup> In advance of filing for implementation of the tariff rider, the Company is providing actual cost data associated with the project based on accounting data through February 28, 2013. The Company anticipates making a similar filing in early April 2013, with actual accounting data through March 31, 2013. The project remains on schedule to be placed in service in mid-May 2013.

The costs of the Mona-to-Oquirrh transmission project are confidential under the protective order in this docket (Order No. 12-060). Due to the voluminous nature of the data, the line item detail from the Company's accounting system is provided only in electronic form on the enclosed CONFIDENTIAL CD.
