On October 20, 2006, PacifiCorp filed Advice No. 06-019 with a requested effective date of November 20, 2006. At the November 7, 2006 Public Meeting, the Commission suspended the filing for further investigation. On April 2, 2007, the Commission entered Order No. 07-120 approving the filing in Advice No. 06-019. The Order required PacifiCorp to 1) file new tariff sheets and standard contracts with new effective dates, and 2) thirty days after the effective date of the revised standard contracts and tariff sheets, refile the standard contracts with the provision "Section 24, Commission Investigation" removed. The current filing complies with the first requirement. We will make another filing to comply with the second provision within 30 days.
