. •	("Idaho Power" or "Company") hereby files its third report of the receipt of proceeds from the	
11	sale of SO <sub>2</sub> emission allowances.	
12	Since the Second Report of Proceeds From SO <sub>2</sub> Allowance Sales was filed on April	
13	10, 2006 ("Second Report"), the Company has received proceeds from the sale of an	
14	additional 20,000 SO <sub>2</sub> emission allowances. The total additional net proceeds received	
15	since the filing of the Second Report is \$11,266,500. The net proceeds amount is the total	
16	amounts received less broker's fees of \$5,000.	
17	In addition, the Company is in the process of negotiating the sale of a second	
18	tranche of SO <sub>2</sub> emissions credits. The Company expects the sale of this second tranche to	
19	close before the end of the year and will make a filing at that time.	
20	The accounting for these proceeds is in accordance with Commission Order 05-983.
