



What is Link Up Support?

Link Up support reduces the one-time cost associated with initiating telephone service and line extension to the consumer's residence. Eligible consumers also qualify for a deferred payment schedule for any remaining costs of up to \$200. Link Up discounts reduce the cost of either wireline or wireless service, but do not offset the cost of purchasing a wireless phone. Link Up does not cover the cost of wiring inside a

home. A consumer may only receive the Link Up discount once, unless that consumer moves to a new residence-consecutive discounts at the same address are not allowed.

Non-tribal Customers

Consumers qualifying for Link Up support are eligible to save 50 percent on installation fees, up to \$30.

Tribal Customers

Eligible low-income consumers living on tribal lands are eligible for an additional discount of up to \$70 to cover 100% of the charges between \$60 and \$130.



- Avoid using something obvious like your name or address when naming your network
- Activate Wireless Encryption Protocol on your router so you block access
- Disable the broadcast so you won't see the access point if you scan with your network card
