1	I, Michael Bowman, hereby declare that the statements below are true to the best of my	
2	knowledge and belief and that I understand these statements are admissible as evidence in	
3	3 legal proceedings and subject to penalty for perjury.	
4	1.	My name is Michael Bowman. I am employed by Salmon Valley Water Company
5		("Salmon Valley" or the "Company") as its General Manager.
6	2.	Public Utility Commission of Oregon (the "Commission") Order No. 21-147, entered
7	May 13, 2021, adopted the uncontested Stipulation between the parties, Salmon	
8	Valley and Staff of the Public Utility Commission of Oregon, filed on March 30,	
9	2021 (the "Stipulation"). Paragraph II.3 of the Stipulation states, in relevant part:	
10	"The Company agrees to file an attestation of a Company officer attesting to the date	
11		upon which the new Foxglove7 well has been placed in service."
12	3.	As of today, July 22, 2021, the Foxglove7 well has been placed in service and is
13		operational.
14	4.	Paragraph II.3 of the Stipulation also states, in relevant part: "If the in-service date of
15		the new Foxglove7 well is after June 24, 2021, then the Phase 1 rate effective date
16		will be the first of the month occurring at least one week after the in-service date of

1	the Foxglove7 well, and the Phase 2 rate effective date will be one year after the
2	Phase 1 rate effective date."
3	5. In accordance with Paragraph II.3 of the Stipulation and in compliance with Order
4	No. 3 of Commission Order No. 21-147, Salmon Valley is separately filing tariffs
5	with an effective date of August 1, 2021 for Phase 1 rates and an effective date of
6	August 1, 2022 for Phase 2 rates.
