Dear Judge Arlow:

Yesterday we received a copy of Universal's purported "reply" to Qwest's May 22, 2006 response to Universal's May 5, 2006 request for reconsideration. However, as the Commission and Universal both well know, a third round of filings is not provided for in OAR 860-014-0095, which is the applicable administrative rule for a motion or request for reconsideration. See Order No. 05-206 (May 3, 2005) in docket ARB 589, at p. 2; Order No. 04-598 (October 18, 2004) in docket UM 1083, at p. 2. (OAR 860-013-0050, which Universal cites, is not the applicable rule for a motion for reconsideration.) Indeed, Universal is well aware of the Commission's policy and rule regarding motion for reconsideration filings because Order No. 05-206 was in docket ARB 589, which was the previous interconnection arbitration proceeding between Qwest and Universal.

Specifically, in docket ARB 589, Universal attempted to file a "reply" on March 31, 2005 to Qwest's response to Universal's motion for reconsideration. However, the Commission's Administrative Hearings Division advised Universal in an email on April 5, 2005 as follows:

Upon further review, your electronic filing number 335, of 3-31-05 [Universal's "reply" to Qwest's response], has been declined by the ALJ. The rules do not provide for a third round of filing, please see Order No. 04-598 for more information. (See Attachment 1.)

Thereafter, Order No. 05-206 specifically ruled:

On March 31, 2005, Universal filed a reply to the application [for reconsideration]. A third round of filings is not provided for in OAR 860-014-0095, and the reply was not considered. See Order No. 04-598 at 2. Order No. 05-206, p. 2 (emphasis added).

Accordingly, there is clearly no basis for Universal's purported "reply." As such, Qwest respectfully submits that the Commission should strike that filing and that it should not consider the reply in its consideration of Universal's motion for reconsideration.
