QWEST'S RESPONSE IN OPPOSITION TO WESTERN'S MOTION TO STRIKE

Pursuant to OAR 860-013-0050(3)(d), respondent Qwest Corporation ("Qwest") hereby responds to the Motion to Strike ("Motion") that petitioner Western Radio Services Co. ("Western") filed on December 27, 2005 in response to Qwest's Request for Official Notice of Utah Commission Order Dismissing Petition for Arbitration ("Request") on December 12, 2005.

The Request asked the Commission to take official notice of the Order Granting Motion to Dismiss ("Utah Order") that the Public Service Commission of Utah ("Utah PSC") issued on December 7, 2005 in connection with Qwest's Response to Petition for Arbitration, Including Motion to Dismiss ("Motion to Dismiss") that Qwest filed on November 8, 2005. Qwest attached a copy of the Utah Order with the Request. The sole basis for Western's Motion was that Western's affiliate, Autotel, had not been served with a copy of the Utah Order, and that the Utah Order was not available on the Calendar/Log section of the Utah PSC website. Notably, however, Western did not claim that the Utah Order was somehow not relevant to the issues pending before this Commission on Qwest's Motion to Dismiss in this docket.

After Qwest received the Motion, it contacted the Utah PSC. The Utah PSC advised that it was unable to confirm that it had served Autotel with the Utah Order on December 7, 2005. However, the Utah PSC did post the Utah Order on the Telecommunications Orders section of its website. In addition, the Utah PSC informed Qwest it was serving the Utah Order on Autotel on

December 27, 2005, both electronically and by regular mail. The Utah PSC has since confirmed to Qwest that it served the Utah Order on that date. Of course, Western also received the Utah Order on December 12, 2005 as an attachment to Qwest's Request in this docket.

In any event, the Utah PSC has issued the Utah Order, and the Utah Order addresses issues substantially similar to those presented by Qwest's Motion to Dismiss in this docket. Whether the Utah PSC formally served Autotel with the Utah Order on December 7, 2005 is irrelevant to the fact that the Utah PSC did in fact issue the Utah Order. In addition, the Utah PSC's December 27, 2005 service of the Utah Order on Autotel renders moot any concern about a lack of service on December 7, 2005.

Based on the foregoing, Qwest respectfully requests that the Commission deny Western's Motion and that it take official notice of the Utah Order in ruling on Qwest's pending Motion to Dismiss the Petition for Arbitration in this docket.
