9                                   **PacifiCorp's Cross Examination Statement**

10           PacifiCorp is filing a Motion in Limine ("Motion") to exclude portions of the  
11    testimony of ICNU witness Ellen Blumenthal concurrently with this Cross Examination  
12    Statement. If the Public Utility Commission of Oregon ("Commission") grants the Motion  
13    and excludes the testimony from the record, PacifiCorp anticipates limited cross-  
14    examination of Ms. Blumenthal, 30 minutes or less.


15           If the Commission denies the Motion, PacifiCorp plans to cross examine  
16    Ms. Blumenthal for approximately 60 minutes.

17           If the Commission grants the Motion in part, the length of PacifiCorp's cross  
18    examination will depend on what portion of Ms. Blumenthal's testimony is excluded.

19           PacifiCorp waives cross-examination of Staff's witnesses Carla Owings and Justin  
20    Ball.
