Pursuant to the Administrative Law Judges' ("ALJs") February 15, 2011 Joint Prehearing Conference Memorandum, the Industrial Customers of Northwest Utilities ("ICNU") submits this notice of intent to cross-examine witnesses in the above-referenced Docket. This cross examination statement is preliminary because PacifiCorp, Staff and the Citizens' Utility Board of Oregon ("CUB") (jointly, "Settling Parties") have not yet fully responded to ICNU's discovery requests, which are not due until noon Thursday, February 24, 2011. ICNU may revise its cross examination statement after the review of the Settling Parties' data responses. In addition, the Settling Parties may sponsor live surrebuttal at the hearing, which could expand the scope of ICNU's cross examination.<sup>1/</sup> ICNU currently wishes to cross-examine the following witnesses:
