Pursuant to the Administrative Law Judges' ("ALJs") February 15, 2011 Joint Prehearing Conference Memorandum, the Industrial Customers of Northwest Utilities ("ICNU") submits this notice of intent to cross-examine witnesses in the above-referenced Docket. This cross examination statement is preliminary because PGE, Staff and the Citizens' Utility Board of Oregon ("CUB") (jointly, "Settling Parties") have not yet fully responded to ICNU's discovery requests, which are not due until noon Thursday, February 24, 2011.
