STAFF CROSS EXAMINATION STATEMENT

8 Pursuant to the Administrative Law Judge’s August 18, 2008 ruling, Staff of the Public
9 Utility Commission of Oregon (“Staff”) submits this statement regarding its intent to cross-
10 examine witnesses in the hearing scheduled in the above-captioned docket.

11 Staff currently intends to cross examine PacifiCorp witness Andrea Kelly for
12 approximately 30 minutes and PacifiCorp witness Mark Tallman for approximately 30 minutes.
13 Staff reserves the right to ask follow-up questions of any witness who is cross examined by
14 another party. Staff may also amend this cross examination statement after review of
15 outstanding data request responses. Staff may also amend this cross examination statement to
16 delete either Ms. Kelly or Mr. Tallman and will do so at the earliest opportunity once such a
17 decision has been reached.

18 Finally, staff has conferred with the other parties concerning the cross examination of its
19 witness Deborah Garcia. Due to a scheduling conflict involving Ms. Garcia, the parties have
20 agreed to conduct her cross examination on September 15, 2008. Staff has conferred with the
21 Administrative Law Judge’s assistant in this regard and has confirmed both the Administrative
22 Law Judge’s availability on that day and reserved a hearings room at the Commission’s offices
23 on the 15th for the continuation of the hearing for this limited purpose. Staff appreciates the
