Pursuant to Administrative Law Judge ("**ALJ**") Memorandum and Ruling of September 25, 2020, the Northwest and Intermountain Power Producers Coalition ("**NIPPC**") submits this supplement to its cross-examination statement for the Commission hearing scheduled on October 8, 2020 to provide additional specificity with respect to the specific pages of pre-filed testimony NIPPC anticipates addressing during the hearing as part of its cross examination.<sup>1</sup>

As previously noted in its Cross Examination Statement, NIPPC anticipates cross examining the panel of witnesses provided by Portland General Electric Company ("**PGE**"), consisting of Karla Wenzel, Josh Halley and Brian Faist (the "**PGE Panel**") with respect to PGE testimony including PGE/500, PGE/600-606, PGE/700-703 and PGE/800-802, as well as with respect to the data responses identified by NIPPC in its cross examination statement.
