Cascade Natural Gas Corporation is on this date filing with the Oregon Public Utility Commission (OPUC) at Salem, Oregon, revisions to its Tariff P.U.C. OR No. 10 to add Schedule 38, Pandemic Cost Recovery, revise Rate Schedule Nos. 101, 104, 105, 111, 163, 170, and 800, and remove Schedule 35, Temporary COVID-19 Residential Bill Assistance Program.

The addition of Schedule 38, Pandemic Cost Recovery and the subsequent addition of the appropriate Schedule 38 charge to each Rate Schedule is made to allocate the deferred incremental costs and benefits associated with the COVID-19 pandemic, including costs for bill assistance, bad debt, and the moratorium on charging reconnection and late fees, net of benefits such as reduced employee travel and COVID-19 tax benefits.

The overall effect of the proposed rate adjustments on the monthly bill of a residential customer with consumption of 61 therms will be a net increase of \$1.18 or 1.60%. For small commercial customers, the average increase will be 0.63%. Large volume core customers will experience an average increase of 0.65% depending on monthly volumes consumed. Large volume interruptible customers will experience an average increase of 0.65%. Large volume noncore customers will experience an average increase of 0.37% for distribution service from Cascade depending on the monthly volumes consumed. The proposed change will increase the company's annual retail revenues by \$1,268,405 or 1.31%.
