

ADV 1600 Schedule Announcement

This announcement provides a proposed schedule to bring ADV 1600 to a public meeting. Staff intends to hold a workshop with the Company and stakeholders, provide a period for written comments, and reserve time for a second workshop if needed.

Background

On February 29, 2024, Idaho Power filed ADV 1600/Advice No. 24-01, which proposes changes to its Oregon Schedule 84 that contains the Company's Oregon on-site generation program. This update would go into effect on June 1, 2024. This proposed change follows Commission Order No. 23-479, which directed the Company to file a revised tariff to Oregon Schedule 84 as soon as possible following the conclusion of docket IPC-E-23-14 in Idaho, which updated the Company's on-site generation offering to its Idaho customers. The Company's proposed changes to its Oregon on-site generation offering in ADV 1600 mimics its Idaho offering apart from a different distinction between legacy and non-legacy customers. The Idaho on-site generation offering was updated in Idaho docket IPC-E-23-14 and became effective on January 1, 2024.

Schedule information

Staff notes that many elements of the case history and program design relevant to the Company's update to Oregon Schedule 84 were discussed extensively in ADV 1539 and in IPC-E-23-14. However, now that the program in Idaho is finalized, Staff still feels that it is important to allow Oregon stakeholders an opportunity to better understand the evolution of the docket in Idaho and its application in Oregon. Staff intends to hold a stakeholder workshop as well as a written comment period, and present Staff's recommendation at a regular public meeting on May 28, 2024. Staff's full schedule is proposed below:
