## AR 654 – Rulemaking for Division 87 Transportation Electrification (TE) Planning

Through Order No. 21-484<sup>1</sup> (December 2021), the Commission adopted Staff’s recommendation to explore the adoption of its Transportation Electrification (TE) Investment Framework in Oregon. The Order also directed Staff to commence a rulemaking in early 2022 to revise Division 87 of Oregon Administrative Rules Chapter 860 to formalize Staff’s recommendations. Staff hosted workshops February 4 and March 16, 2022 to kick off the process and explore TE portfolio budgeting, including use of ODOT’s *TE Infrastructure Needs Analysis (TEINA)* methodology.

Staff invites stakeholders to attend a **third public workshop Friday, April 1, 2022, 2 – 4 pm Pacific Time**. At the workshop, Staff will lead a discussion of stakeholder feedback on Staff’s revised Division 87 rules, Staff’s initial responses, and open items. In advance of the workshop, Staff will publish a summary of stakeholder comments and initial Staff responses, as a basis for discussion. After the workshop, Staff will then publish a second revision to the rules, for additional public comment.
