NOTICE OF INTENT TO REQUEST AN ISSUE FUND GRANT OF THE CITIZENS' UTILITY BOARD OF OREGON

The Citizens' Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in LC 62, pursuant to OAR 860-001-0120 and the Second Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 12-452 (November 20, 2012).

- PacifiCorp will file its 2015 Integrated Resource Plan next year. The Commission will examine this filing in Docket No. LC 62.
