Pursuant to Section 6.7 of the Fourth Amended and Restated Intervenor Funding Agreement ("IFA") approved by the Oregon Public Utility Commission ("Commission") in Order No. 18-017 (January 17, 2018), the Alliance of Western Energy Consumers ("AWEC") hereby files this Request for Amendment of Proposed Budget in Docket No. LC 70 (the "Proceeding"), seeking an increase of \$17,696.94 to its approved Issue Fund Grant in this Proceeding, for a new grant in the amount \$22,577.02.

On September 25, 2019, AWEC filed a Request for Issue Fund Grant and Proposed Budget in Docket No. LC 70 in the amount of \$4,880.08. On September 27, 2019, the Commission approved an Issue Fund Grant for AWEC in the amount of \$4,880.08 by Order No. 19-320. AWEC is now requesting an amendment to its authorized budget, showing eligible expenses of \$28,221.28 and seeking an Issue Fund Grant in the amount of \$22,577.02. AWEC requests that the \$17,696.94 in unused funds in its approved Issue Fund Grant in Docket No. UE 356 be reallocated for use in this Proceeding.

Article 6.7 of the IFA states:

<u>Amendment of Proposed Budget</u>: At any time during the proceeding, an intervenor who received Commission approval for an Issue Fund Grant may file to amend its PAGE 1 – AWEC REQUEST FOR AMENDMENT OF PROPOSED BUDGET

budget and request additional funding due to unforeseen changes in the scope or complexity of issues, position taken by other parties, changes in the schedule of the case, or other good cause.

AWEC seeks approval to amend its authorized budget to account for expected increased costs of AWEC's participation in this Proceeding, as Docket No. LC 70 is anticipated to require a substantial time commitment.

Pursuant to Article 6.1 of the IFA, AWEC is concurrently filing a Request for Final Payment and Reallocation of Issue Fund Grant in Docket No. UE 356.

Therefore, AWEC respectfully requests that the Commission issue an order granting AWEC's Request for Amendment of its Proposed Budget in this Proceeding.
