Re: Docket LC 79 – In the Matter of Northwest Natural Gas Company, d/b/a NW Natural, 2022 Integrated Resource Plan

To Interested Parties:

On October 19, 2022, the Administrative Law Judge issued a memorandum setting forth the LC 79 procedural schedule.¹ This schedule included a Special Public Meeting on November 1 for Northwest Natural to make a presentation on its 2022 Integrated Resource Plan (IRP). On October 31, the Special Public Meeting was canceled due to Northwest Natural personnel being unavailable to present.²

With this letter, Staff respectfully requests two changes to the procedural schedule. The first is to reschedule Northwest Natural's presentation from November 1 to November 15. The second is to move the date for Staff/Intervenor/Public Comments from December 21, 2022, to December 30, 2022.

PUC Staff consulted with all intervening parties. All parties either support or do not oppose the proposed schedule modifications.
