C. A NARRATIVE DESCRIPTION OF THE AFFILIATED ENTITY WITH
WHICH THE REGULATED UTILITY DOES BUSINESS.

- MDU Resources Group Inc. - Parent Company to Cascade Natural Gas Corporation. Provides management/consulting/legal services to Cascade Natural Gas Corporation.
- Knife River Corporation - A subsidiary of MDU Resources which provides asphalt services for Cascade Natural Gas Corporation. In addition, Cascade Natural Gas provided distribution system transportation (Tariff Schedule 163) for a Knife River subsidiary company in Central Oregon.
- Loy Clark Pipeline Company, Inc. – Part of MDU Construction Services Group, Inc. and an indirect, wholly-owned subsidiary of MDU Resources Group, Inc. Loy Clark specializes in construction services to the gas pipeline transmission and distribution industry.
- WBI –Part of WBI Holdings, Inc. and an indirect, wholly-owned subsidiary of MDU Resources Group, Inc. Provides 24/7 gas control monitoring of Cascade’s distribution system and provides notification to the appropriate personnel. WBI currently does all monitoring of the SCADA system for Montana-Dakota Utilities. WBI owns and operates 3,700 miles of transmission, gathering and storage lines and owns or leases and operates thirty compressor stations located in the states of Montana, North Dakota, South Dakota, and Wyoming. Additionally, the company entered into a software licensing arrangement whereby Cascade can utilize WBI’s FLOWCAL measurement accounting software. WBI owns the FLOWCAL software designed to

manage electronic flow measurement data in the natural gas industry and to validate volumes and energy for pipeline operations.
