PacifiCorp respectfully submits this notice of withdrawal of its application requesting an order approving an automatic adjustment clause related to net power costs pursuant to ORS 757.210(1). PacifiCorp originally filed its application and proposed Schedule 99 on April 15, 2005. On May 2, 2006, PacifiCorp filed a motion to stay the docket for 60 days pending possible resolution of this matter with other parties. On May 3, 2006, PacifiCorp's request was granted and this proceeding was stayed for 60 days.

Although PacifiCorp was not able to resolve this matter with other parties,

PacifiCorp's decision to withdraw this pending application is based on additional feedback
that was provided throughout this process by the parties, as well as the Commission's
recent action in instituting an investigation into performance-based ratemaking
mechanisms. At the Commission's public meeting on August 22, 2006, the Commission
approved the Staff's request to open an investigation regarding performance-based
ratemaking mechanisms which is expected to provide additional guidance for cost recovery
of power purchase agreements and/or power cost adjustment mechanisms. Moreover, as
part of the recent discussions in Docket No. AR 499 it has been suggested that an
adjustment mechanism may be a viable tool to mitigate potential impacts resulting from
the "double whammy" effect created by Senate Bill 408.

While substantial work was undertaken in this docket, PacifiCorp anticipates that

the Commission's final order implementing permanent rules in Docket No. AR 499 and

the outcome of the new performance-based ratemaking investigation will further inform

the development of any future power cost adjustment mechanisms and believes that all

parties will be better served by its withdrawal of the existing proposal at this time.

Accordingly, PacifiCorp respectfully withdraws its application and proposed

Schedule 99 from further consideration by the Commission in this docket.
