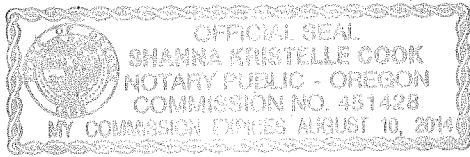
- RESPONSE TO ICNU'S TESTIMONY ON PART 1 OF THE STIPULATION (CUB, STAFF AND PACIFICORP)
