REQUEST FOR PAYMENT OF THE CITIZENS' UTILITY BOARD OF OREGON

Pursuant to Section 7.3 of the Intervenor Funding Agreement (IFA), which was adopted in Order No. 03-388, the Citizens' Utility Board submits this final request for payment of \$9,275 in eligible expenses in docket UE 189 from the PGE Issue Fund. CUB is automatically precertified under Section 5.3 of the IFA.

On April 25, 2007, CUB submitted a proposed budget of \$19,983, assuming a fully litigated case, including testimony, briefs, a hearing, and oral argument. On May 11, 2007, in Order No. 07-182, the Commission approved CUB's budget.

Under Section 7.3 of the IFA, each Issue Fund Grand Request for Payment must:

- (1) Itemize the expenses, payees, and hourly rates of amount to be reimbursed;
- (2) Demonstrate that the expenses are reasonable and are directly attributable to issues and positions pursued on behalf of a particular customer class and consistent with the intervenor's proposed budget; and
- (3) Provide information sufficient to show that the intervenor has complied with any conditions imposed on the Issue Fund Grant.

Order No. 07-182 did not include any additional conditions beyond those anticipated in the IFA.

On August 2, 2007, CUB requested a partial payment of \$1,755. On August 8, 2007, in Order No. 07-340, the Commission approved that request. The combination of this final request for \$9,275 and the previous payment of \$1,755 would be \$11,030.

The expenses incurred are reasonable and directly attributable to the issues and positions CUB addressed in UE 189 on behalf of residential customers. In support of this assertion, we supply Attachment A, a summary of CUB's expenses in this case; Attachment B, an invoice of CUB's costs categorized by activity; and Attachment C, an invoice of CUB employee activity by individual. These documents should allow the Commission to track the time spent on the elements of the case, and we believe that this filing meets the requirements of the Commission.

This is CUB's final request for payment in UE 189, and any further budgeted amounts may be released to the PGE Issue Fund.
