Pursuant to the letter dated May 28, 2009, the Industrial Customers of Northwest Utilities ("ICNU") have reached an agreement with both the Citizens' Utility Board of Oregon ("CUB") and the Klamath Water Users Association ("KWUA") regarding the PacifiCorp issue fund, and submit this revised budget in OPUC Docket Numbers UE 207 and UE 210.

After meeting with CUB and KWUA, ICNU has agreed to lower its proposed budgets in both dockets by a combined \$43,000, and KWUA has agreed to lower its proposed budget in UE 210 by \$12,000. Attached are ICNU's revised budgets to reflect this change. The total amounts that ICNU actually expects to spend in UE 207 and UE 210 far exceed the budgeted requests. Additionally, ICNU and CUB have agreed to co-sponsor experts Ellen Blumenthal and Michael Gorman in Docket No. UE 210.
