The Oregon Industrial Customers of Idaho Power ("OICIP") hereby conditionally withdraw the objection to the stipulation filed in this docket on December 17, 2009, and withdraw the request for oral argument. Counsel for OICIP has contacted the other parties regarding this notice, and no party opposes OICIP's requests and withdrawals contained herein.

OICIP objected to the stipulation on the ground that OICIP had unaddressed concerns about service quality, and filed testimony in support of its objection on January 19, 2010. OICIP now withdraws its objection to the stipulation on the condition and understanding that the Commission will address the service quality issue in a separate complaint or investigatory proceeding, which OICIP will initiate in the near future. OICIP will soon also file a motion to admit into the record in this UE 213 docket OICIP's testimony and exhibits filed on January 19,

2010, which OICIP will request to have noticed or lodged in the separate complaint or investigatory proceeding.

Additionally, OICIP withdraws its request for oral argument in this UE 213 docket, initially filed on January 26, 2010.
