The Citizens Utility Board of Oregon (CUB) files this Notice of Intent to Request an Issue Fund Grant in UE 222, pursuant to OAR 860-012-0100 and the First Amended and Restated Intervenor Funding Agreement (IFA), approved by the Oregon Public Utility Commission (Commission) in Order No. 07-576 (December 20, 2007).

- Idaho Power has filed for its 2011 Annual Power Cost Update. The Commission will examine this filing in Docket No. UE 222.
- 2. UE 222 is an Eligible Proceeding under the IFA. The IFA defines an Eligible Proceeding as "any Commission proceeding that directly affects one or more of the Participating public Utilities." IFA, Section 1(c).
- 3. UE 222 will directly affect Idaho Power which is a Participating Public Utility under Section 1(k) of the IFA.
- 4. As required by IFA Section 6.2, this Notice of Intent is being served on each affected Participating Public Utility, all precertified organizations, and all parties identified on the service list from UE 222.

- 7. CUB will file a proposed budget with respect to the Issue Fund Grant, as provided in Section 6.3 of the IFA.
