

Pursuant to Administrative Law Judge Hardie's June 13, 2011 Ruling and Notice, the Industrial Customers of Northwest Utilities ("ICNU") submits this letter withdrawing its motion to compel. PacifiCorp has provided ICNU with documents sufficient to respond to ICNU's data requests regarding the official forward price curve. PacifiCorp and ICNU have also reached an agreement that ICNU shall have an extension to file testimony on the issue of the development of hourly scalars for the forward price curve. PacifiCorp agrees that the new due date is July 5, 2011. ICNU agrees to use best efforts to file the testimony by 3:00 pm that day. ICNU will submit testimony on other issues related to the forward price curve in its testimony due on June 24, 2011. Please let me know if ICNU should formally file a motion to revise the schedule in this case.
